# **GYPSOL**

This Agrément Certificate Product Sheet<sup>(1)</sup> relates to Gypsol, a calcium sulfate binder for use in the production of self-levelling floor screeds used for indoor use on domestic and non domestic buildings, to produce a smooth, level surface for the subsequent application of a textile or resilient floor covering.

(1) Hereinafter referred to as 'Certificate'.

**Durability** — a screed containing the product, when correctly installed, covered by a suitable floor covering and suitably maintained, will have a life equal to that of the building in which it is installed (see section 9).

# **Technical Specification**

## 1 Description

- 1.1 Gypsol is a calcium sulfate binder for incorporation into fine aggregate/sand and water mixes, for the production of a pumpable self-levelling floor screed.
- 1.2 A typical screed incorporating the product has the following nominal characteristics:

#### 2 Manufacture

- 2.1 The product is manufactured in a continuous blending process.
- 2.2 As part of the assessment and ongoing surveillance of product quality, the BBA has:
- agreed with the manufacturer the quality control procedures and product testing to be undertaken
- assessed and agreed the quality control operated over batches of incoming materials
- monitored the production process and verified that it is in accordance with the documented process
- evaluated the process for management of nonconformities

- checked that equipment has been properly tested and calibrated
- undertaken to carry out the above measures on a regular basis through a surveillance process, to verify that the specifications and quality control operated by the manufacturer are being maintained.
- 2.3 The management system of the manufacturer has been assessed and registered as meeting the requirements of BS EN ISO 9001 : 2015 by Lucideon CICS Ltd (Certificate 24495).

### 3 Delivery and site handling

- 3.1 The product is available packaged in 25kg sacks, 1 tonne bulk bags, or 30 tonne tankers.
- 3.2 The sack and bulk bag packaging bears the Certificate holder's name, product name, batch number and Health and Safety information.
- 3.3 The product must be stored in the sealed original containers or suitable bulk silos in a dry environment at temperatures between 5 and 25°C and has a shelf-life of 12 months when stored under these conditions.
- 3.4 The Certificate holder has taken the responsibility of classifying and labelling the product under the *CLP Regulation* (EC) No 1272/2008 on the classification, labelling and packaging of substances and mixtures. Users must refer to the relevant Safety Data Sheet(s).
- 3.5 As when handling other calcium sulfate-based products, suitable personal protective clothing and equipment should be used when installing and abrading the product (see section 14.3 of this Certificate).

# **Assessment and Technical Investigations**

The following is a summary of the assessment and technical investigations carried out on a screed containing Gypsol.

# **Design Considerations**

#### 4 Use

- 4.1 Gypsol is satisfactory for use as a calcium sulfate binder for incorporation into fine aggregate/sand and water mixes, for the production of a pumpable self-levelling floor screed for fully bonded, unbonded and floating floor constructions on concrete substrates, in domestic and non domestic buildings.
- 4.2 A screed incorporating the product is applied to a suitably prepared and adequately strong sub base to BS 8204-7 2003, and covered with a textile or resilient floor covering. The Certificate holder should be consulted for a suitable mix design for a particular application.
- 4.3 A typical design<sup>(1)</sup> mix for a screed incorporating the product is:

Gypsol 700 kg
 Sand 1,215 kg
 Water 291 l.

- (1) Design mix for Gypsol Classic screed, other screeds may require additional testing or assessment to confirm performance requirements
- 4.4 A screed incorporating the product is for use on<sup>(1)</sup>:
- in-situ suspended floors
- precast floor slabs
- ground-floor slabs
- beam and block floors
- other adequately strong sub base to BS 8204-7 2003.
- (1) The Certificate holder should be consulted for the design of a particular installation.

- 4.5 The designer should ensure that the construction programme allows sufficient time for a base slab to dry adequately before a screed incorporating the product is applied. Where these conditions cannot be met a damp-proof membrane (dpm) should be installed between the base and the screed, in unbonded or floating screed construction.
- 4.6 A screed incorporating the product can be applied at temperatures between 5 and 30°C using normal flowing floor screeding techniques, at the thicknesses shown in Table 1, depending on installation details, the use of the building and the anticipated imposed loads.

<sup>(1)</sup> Minimum overall screed thickness of 40 mm must be used.

4.7 A screed incorporating the product is suitable for use as floating screed, applied to insulating boards with a minimum compressive strength of 100 kPa laid on a suitably prepared base. Precautions are necessary to prevent the screed from penetrating below the boards, by means of lapped and taped membranes.

# 5 Practicability of installation

Screed mixes containing the product can be placed, by operatives with experience of using methods and equipment, using conventional flowing floor screed-laying techniques.

# 6 Strength and stability

- 6.1 A screed incorporating the product can be designed to have adequate strength for use on concrete bases or other suitable bases and has adequate resistance to normal loading, point loading and loads associated with light-wheeled traffic (eg trolleys used in hospitals and offices).
- 6.2 A screed incorporating the product can be designed to have satisfactory resistance to impact and may be laid without serious cracking, and will have a sound surface. The product may be installed effectively to comply with categories A, B or C of BS 8204-1: 2003, as shown in Table 2 of this Certificate.

6.3 A screed incorporating the product has similar movement characteristics to a good quality concrete.

#### 7 Resistance to wear and surface hardness

A screed incorporating the product, under normal circumstances, will resist the wear from light foot traffic better than sand/cement levelling screeds. However, where following trades are to work in an area of uncovered screed, it is recommended that the screed be protected with a temporary covering.

#### 8 Maintenance

- 8.1 Under normal circumstances, maintenance or repair of a screed incorporating the product will not be necessary. However, in common with other screeds, the product should be protected from moisture.
- 8.2 If damage or cracking occurs, repairs may be readily achieved by cutting out the damaged area and re-laying. Minor cracks may be repaired using a suitable remedial compound.

### 9 Durability

A screed incorporating the product is durable and, when correctly installed, covered by a resilient floor covering and suitably maintained in a dry environment, will have a life equal to that of the building in which it is installed.

#### Installation

#### 10 General

- 10.1 A screed incorporating the product should only be installed by operatives with relevant experience using conventional flowing floor screed-laying techniques in accordance with BS 8204-1: 2003, BS 8204-7: 2003, the Certificate holder's installation instructions and this Certificate.
- 10.2 A screed incorporating the product must be installed within three hours of mixing.
- 10.3 The product is applied on a suitably prepared sub base at the thicknesses given in Table 1. Care should be taken to ensure that the minimum thicknesses are achieved at the maximum point of departure from the datum of the base.
- 10.4 The standard of installation of a screed incorporating the product should generally comply with BS 8000-0: 2014.
- 10.5 Low temperatures or excessive moisture in the underlying sub base will delay the hardening and drying times of the screed.
- 10.6 In common with other self-levelling screeds, a screed incorporating the product is not suitable for use on floors with a significant fall.
- 10.7 A screed incorporating the product is not suitable for use as a final wearing course and should be finished using a resilient floor covering or floor topping.
- 10.8 The advice of the Certificate holder should be sought if a screed incorporating the product is to be used with underfloor heating systems.

# 11 Preparation

- 11.1 The sub base must be prepared in accordance with BS 8204-1: 2003 and BS 8204-7: 2003, and be structurally sound, clean, and free from laitance, organic or other extraneous matter which might impair adhesion of the screed. Any weak or yielding substrate must be removed.
- 11.2 A sub base should be cleaned and any projections removed and cavities filled to achieve a reasonably regular surface.

- 11.3 A screed incorporating the product is applied by pump direct from the ready-mix truck or on-site volumetric mixers. Owing to the very fluid nature of the product, the substrate must be capable of holding liquid to the required depth.
- 11.4 Only sand, graded aggregates and water sources approved by the Certificate holder may be used when producing the screed.

#### **Bonded screeds**

- 11.5 The sub base is prepared either by shot-blasting or scabbling, and vacuum cleaned to completely remove any laitance and expose the main aggregate.
- 11.6 Any holes or gaps in the substrate must be filled, sealed and left to set prior to screeding in accordance with the Certificate holder's instructions.

### **Unbonded and floating screeds**

- 11.7 When used for unbonded or floating floor constructions, all joints in the plastic membrane or insulation are sealed or taped in accordance with the membrane/insulation suppliers' recommendations.
- 11.8 A suitable dpm should be included into the build-up below the screed and the surface kept clean prior to screeding.
- 11.9 For floating construction, the insulation must be overlaid with lapped and taped polythene sheeting of appropriate thickness. Compressible foam strips must be placed around perimeters and vertical upstands, and thresholds, stairs and drain gullies should be isolated prior to the screed laying.

# 12 Application

- 12.1 Application of screed incorporating the product must be conducted in accordance with this Certificate and the Certificate holder's instructions. The Certificate holder can advise on suitable equipment for this purpose.
- 12.2 Upon delivery to site and rheological check, a screed mix incorporating the product is pumped onto the prepared surface via a discharge hose. The hose is moved across the surface at a constant rate and dappled twice, in order to achieve a uniform level surface.
- 12.3 Prior to completion of screeding, checks must be made on the thickness using levelling tripods and/or laser levelling.

# 13 Curing

To avoid the screed from drying out too quickly in the first 48 hours, the finished installation should be protected from draughts, strong sunlight, hot weather and excessive temperatures.

### 14 Finishing

- 14.1 Once laid, a screed incorporating the product can be subjected to light foot traffic after 24 to 48 hours, depending on ambient conditions. This time will be extended at lower temperatures. The room should be ventilated after 48 hours to 7 days by opening windows and doors to aid the drying process.
- 14.2 The flooring contractor must check the moisture content of the screed before laying the floor covering in accordance with the recommendations of BS 8203 : 2017. Typically, floor coverings can be installed after three to five weeks, depending on the screed thickness and drying conditions.
- 14.3 A screed incorporating the product may require sanding to remove laitance, but it is recommended to lightly abrade the surface to clean and remove any building residue and to improve the adhesion of the flooring adhesive to the hardened screed.

### **Technical Investigations**

#### 15 Tests

Tests were carried out on a screed incorporating the product and the results assessed to determine:

- compressive strength
- flexural strength
- resistance to indentation.
- bond strength
- static loading
- shrinkage and expansion
- setting time
- crushing resistance.

# 16 Investigations

16.1 The manufacturing process was evaluated, including the methods adopted for quality control, and details were obtained of the quality and composition of the materials used.

16.2 An assessment was made of the practicability of installation, for a typical screed mix incorporating the product.
